



## Don't have your 5F licence yet? No problem!

If you have a Manitoba 5I licence (or equivalent), you can still join Peg City Car Co-op. We require these drivers to join as a **Member**.

Members must purchase a \$500 share. If you're more than 30 days away from earning your 5I, an additional \$500 deposit is required. Once you've earned your 5F, we'll be glad to refund the additional \$500 to you. Member shares are fully refundable, meaning you receive the funds back in full 60 days after you close your account and leave the Co-op.

5I applicants must submit a clear driving history to be eligible. You may not join the Damage Pool until you've earned your 5F licence. If a 5I driver is in an at-fault collision with a Peg City vehicle, you may be responsible for damages up to \$800, as outlined in our Member Manual. Once you've earned your 5F with a clear driving history, you're welcome to join one of the Damage Pool programs, which can reduce your damage responsibility to as little as \$0.

Step 2: Driving History, Forms, and ID verification

1. You'll need to request your driving history from MPI and submit it along with your application and forms. Driving histories can take five business days to process. [You can find instructions for requesting your driving history in Manitoba here.](#)



2. Complete and form at the end of this document.
3. Take two photos: one clear photo of your current driver's licence and another clear photo of you holding the licence. If your driver's licence does not have a photo, we will still need a clear photo of it along with a photo of another form of government-issued photo ID and a photo of you holding that government-issued photo ID.

Step 3: We will review your application once all required documents are received. We will contact you to arrange the \$500 deposit and let you know if further steps are needed before we activate your account. Thank you!

### **Why do we have eligibility requirements?**

To keep our rates affordable, we must do everything we can to minimize the risk of damage to our fleet. In general, we require that members have at least three years of driving history and that they meet our eligibility criteria. We understand this requirement can be prohibitive and have developed this program to show fairness while mitigating risk.
