



Want to add a learner to your account? No problem!

If you're a shareholding member with a 5F licence or equivalent, you're welcome to add someone with a learner's licence or 5L to your account.

Adding a 5L driver to your account comes with special conditions. First, you'll need to pay a \$500 deposit in addition to your member share. Once the learner has graduated to a 5F licence or left the account, we'll be glad to refund that \$500 to you. Member shares are also fully refundable, meaning you receive the funds back 60 days after you close your account and leave the Co-op.

Drivers with a 5L licence will not receive their own fob or app access. Instead, they will be permitted to drive on bookings associated with your account so long as they are supervised by a driver with a full licence on the account.

Accounts with a 5L licenced driver are not eligible for our Damage Pool program. That means drivers on the shared account with the 5L driver are also not eligible for our Damage Pool program. If any driver on the account is in an at-fault collision with a Peg City vehicle, you may be responsible for damages up to \$800, as outlined in our Member Manual. If a 5L driver is in a collision without supervision, their licence is deemed invalid, and all costs associated with the collision will be passed down to the account holder. If a 5L driver is found driving unsupervised regardless of collision, the account will be closed.



The learner will gain app and fob access and is eligible to drive unsupervised once they've demonstrated proof of their 5L licence with a clear driving history.

After earning their 5F with a clear driving history, we'll be glad to refund your \$500 deposit, and everyone on the account is welcome to join the Damage Pool, which can reduce your damage responsibility to as little as \$0. It is the member's responsibility to inform Peg City of any licence changes.

Step 2: Driving History, Forms, and ID verification

1. Complete the form at the end of this document.
2. Take two photos: one clear photo of the 5L licence and another clear photo of the learner holding the licence. If the licence does not have a photo, we will still need a clear photo of it along with a photo of another form of government-issued photo ID and a photo of the learner holding that government-issued photo ID.
3. Send your completed form and photos to info@pegcitycarcoop.ca

Step 3: We will review your application once all required documents are received. We will contact you to arrange the \$500 deposit and let you know if further steps are needed before we activate your account. Thank you!
