



No Driving History? No problem!

If you cannot obtain your driving history (also known as a driver abstract), you can still join Peg City Car Co-op. We require drivers without a driving history to join as a **Member**.

Members must purchase a \$500 share. This share is fully refundable, meaning you receive it back in full 60 days after you close your account and leave the Co-op.

Members without a driver abstract are not eligible to join the Damage Pool and may be responsible for damages up to \$1000, as outlined in our Member Manual. After one year of damage-free driving, you may be eligible to join the Damage Pool, which reduces your damage responsibility to \$0.

Step 1: Read the [Member Manual](#). If you have any questions, please contact our Member Services team.

Step 2: Member Eligibility Declaration and ID verification

1. Please download and fill out the Member Eligibility Declaration form at the end of this document.
2. Take two photos: one clear photo of your current driver's licence and another clear photo of you holding the licence. If your driver's licence does not have a photo, we will still need a clear photo of it, a clear photo of another form of government-issued photo ID, and a clear photo of you holding that government-issued photo ID.



3. Send your completed form and photos to info@pegcitycarcoop.ca

Step 3: We will review your application once all required documents are received. We will contact you to make the \$500 share payment and let you know if further steps are needed before we activate your account. Thank you!

Please note that if, while converting your licence to a Manitoban one, your licence shifts to a Manitoba 5A without a 5F, you must notify Peg City and [follow the requirements of our 5L program.](#)

Why do you have eligibility requirements?

To keep our rates affordable, we must do everything possible to minimize the risk of damage to our fleet. We require driving history from all drivers with Peg City Car Co-op to confirm that they meet our eligibility criteria. We understand that it can be difficult or impossible for some drivers from out of province to obtain your driving history document. For that reason, we've created this Member Eligibility Declaration.
