



Want to add a learner to your account? No problem!

If you're a shareholding member with a 5F licence or equivalent, you are welcome to add someone with a learner's licence or 5L to your account. Not already a co-op member? Review our [Member Manual](#) and [sign up today!](#)

Adding a 5L driver comes with special conditions. First, you'll pay a \$500 deposit in addition to your member share. Payment can be made by e-transfer or credit card on file. Once the learner has graduated to a 5F licence or left your account, we'll gladly refund the \$500.

5L drivers will not receive their own fob or app access. Instead, they'll be permitted to drive on bookings associated with your account. During these bookings, the learner must be supervised by a full licence driver authorized on your account (see Additional Driver terms in our Member Manual).

Accounts with a 5L licensed driver are not eligible for our Damage Pool program. This means every driver on your account becomes ineligible for the Damage Pool when you add a 5L driver. Basically, if you or an additional driver are in an at-fault collision with a Peg City vehicle, you or the driver may be responsible for damages up to \$800, as outlined in our Member Manual. If a 5L driver is in a collision without the required supervision, their licence is deemed invalid, and all associated costs (over and above \$800) will be your responsibility as the account holder. Your account will be closed if a 5L driver is found driving unsupervised, regardless of collision.



Once the learner has demonstrated proof of their 5L licence with clear driving history, they will gain app and fob access and can drive unsupervised. We'll happily refund your \$500 deposit once they've earned their 5F with a clear driving history. At that point, everyone on the account is welcome to join the Damage Pool, which can reduce your damage responsibility to as little as \$0. As the account holder, you must inform Peg City of any licence changes.

Ready to add a 5L driver to your account?

Step 1: Read the [Member Manual](#) with the applicant. Please contact our Member Services team if questions arise.

Step 2: Driving History, Forms, and ID verification

1. Complete the form at the end of this document.
2. Take two photos: one clear photo of the front of the 5L licence, one of the back, and another clear photo of the learner/applicant holding the licence. If their licence does not have a photo, we will still need a picture of it along with a photo of another form of government-issued photo ID and a photo of the learner/applicant holding that photo ID.
3. Send your completed form and photos to info@pegcitycarcoop.ca.

Step 3: We will review your application once we've received all required documents. Next, we'll contact you to arrange the \$500 deposit and let you know if further steps are needed before we activate your account.
